IMPORTANT INFORMATION: NOTICE OF NON-RENEWAL

Dear Valued Customer:

This notice contains important information about your current coverage and the next steps you **MUST** take. Pursuant to N.J.A.C. 11:21-16, Horizon has submitted notice to the New Jersey Department of Banking and Insurance (DOBI) to withdraw small employer transitional/ Pre-Affordable Care Act (ACA) health and prescription drug plans from the marketplace.

As a result, **your current group health plan and any applicable prescription plan will not be available as of your upcoming anniversary date.**

The withdrawal of these plans is being applied uniformly and is not based on the claims experience of your group or any health-related factors of current or future members.

What You Need to Know

- Your current group plan and prescription plan if applicable will not be renewed as of your anniversary date, **<insert date>**, and coverage will end on that date.
- If you are an eligible small employer, you may continue coverage with Horizon by selecting new coverage from our portfolio of health and prescription drug plans prior to your anniversary date.

Eligibility and Enrollment Reminders

To enroll in a new small employer ACA-compliant health plan, you must meet small employer eligibility requirements, including having common-law employees. Groups consisting solely of a sole proprietor, a partner in a partnership, or only a spouse or family members are not eligible for small employer group coverage.

In addition, you must also complete a **Small Employer Certification Form** confirming eligibility. You may have already received this form, or it will be sent to you prior to renewal, and it must be completed before enrollment can occur. Contact your broker if you have any questions.

Employers that are not eligible for small employer coverage may need to consider

individual health coverage options, if eligible.

Your Next Steps

- Contact your broker as soon as possible to review your options and complete the necessary steps before your anniversary date. It's important that you speak with your broker at least 15 days before your upcoming anniversary date to discuss your health and prescription drug plan options. - Once received, complete and return the **Small Employer Certification Form**, which is required to enroll in new coverage.
